**TERMS & CONDITIONS**

The following is a summary of the Rental Conditions. Please note that all prices are quoted in South African Rand. Rates quoted in our brochures and / or conditions are subject to change without notice.

**RENTAL DURATION**

Minimum rental is 5 days, subject to collection / return depots. When calculating the number of days, the day of collection is counted as day one of the rental regardless of collection time. The day of return is counted as the final day.

**DEPOT HOURS FOR PICK-UP & DROP-OFF**

Motorhome Express has branches in Windhoek, Johannesburg and Cape Town. Port Elizabeth and Durban are handled at the airport (other cities on request). Office hours are Monday to Friday from 07h30 to 16h30. Collections and returns on weekends and public holidays by arrangement only.

**TRANSFER**

**EXCESS REDUCTION OPTIONS**

We offer 3 very competitive excess reduction options for peace of mind during your holiday: **Contact** us for further details.

**ACCIDENTS**

- ▶ If the rental vehicle is involved in an accident and is not driveable, a replacement vehicle, if available, may be collected from the closest branch.
- ▶ If the hirer requires a replacement vehicle to be delivered, then these charges will be for the hirer's account. None of the excess reduction options cover this eventuality.
- ▶ The hirer is responsible for the recovery of the damaged vehicle to the original rental depot.
- ▶ If the hirer is unable or unwilling to take a replacement vehicle, no refunds for early termination of the contract will apply.
- ▶ No refund of rental days lost will be considered during the period in which a replacement vehicle is being organised.
- ▶ Should there be no replacement vehicle available; no refund for lost rental days will be considered.
- ▶ Should the hirer continue with a replacement vehicle then a new rental contract and insurance conditions will apply.

Motorhome Express reserves the right to apply the above conditions as they deem fit.

## EXCLUSIONS

The hirer will be fully liable for any damage to the camper or third party vehicle / property if:

- The terms of the rental contract are breached.
- Damage to the vehicle is caused by careless, wilful, or reckless driving.
- Damage to the vehicle is caused due to incorrect use of clutch, handbrake etc.
- Driving under the influence of drugs or alcohol.
- Driving on restricted roads / areas.
- Water submersion or salt-water damage is caused.

In case of any damage to the camper or third party vehicle / property a second excess will be collected to cover the excess for any subsequent damage.

## INFRINGEMENTS

The hirer will be liable for any speeding or parking fines, associated administration costs, and / or accidents including third party vehicle / property damage not reported on the return of the vehicle.

## EXCHANGE RATE / CURRENCY VARIATIONS

All credit card transactions are conducted in South African Rand. Due to exchange rate fluctuations there could be some variance in the amount refunded compared to the amount initially charged. Motorhome Express accepts no liability for any variances up or down.

## CREDIT CARDS

If a credit card is presented as payment, the credit card holder will be jointly and severally liable as a customer. The cardholder of the credit card presented for payment, has to be present on collection of the camper.

## LICENCE

A valid non-endorsed driver's licence is required - international licence is **required together with the national licence**. In Namibia it is law for non-SA citizens to have an international licence.

## MINIMUM AGE

Drivers must be 21 years or older – **23 years for the Discoverer-X**.

## ROAD RESTRICTIONS

Vehicles may be taken into South Africa's neighbouring states but are not allowed into Angola, Zimbabwe, Mozambique or Malawi. All insurance cover is void if vehicles enter prohibited areas.

Motorhome Express reserves the right, at its sole discretion, to restrict vehicle movements in certain areas due to adverse road or weather conditions, political situations or any other reason.

## CHANGE OF VEHICLE

Motorhome Express reserves the right to substitute a comparable or superior vehicle should the requested vehicle not be available due to unforeseen circumstances. This shall not constitute a breach of contract and does not entitle the hirer to any refund.

## **CANCELLATION FEES**

- If cancelled 3 months prior to pick-up = 10 %
- If cancelled 2 months prior to pick-up = 25%
- If cancelled 1 month prior to pick-up = 50 %
- If cancelled 1 week / no show = 100 %

**If vehicle is returned early for any reason, no refund will be considered.**

## **TAXES**
